Outstanding CIRP Dues for the period 3rd April, 2018 to 17th April, 2023

This is to inform you that Unimark Remedies Limited was undergoing Corporate Insolvency under the provisions of the Insolvency and Bankruptcy Code 2016, ("IBC") vide the Hon'ble National Company Law Tribunal, Mumbai Bench ("Hon'ble NCLT, Mumbai") order dated 3rd April 2018 wherein insolvency professional, Mr. Amit Gupta, (having IP Registration no. any costs incurred at the expense of the Government to facilitate the insolvency resolution process; and

Thus, the amount due to you as Creditor between the period of 3rd April 2018 to 17th April, 2023 would be considered and included as a part of CIRP cost subject to approval of the Committee of Creditors.

Additionally, as per Section 30(2) of The Insolvency and Bankruptcy Code, 2016, The resolution professional shall examine each resolution plan received by him to confirm that each resolution plan-

- a) provides for the *payment of insolvency resolution process costs in a manner specified by the Board in priority to the payment of other debts* of the corporate debtor;
